- May AP Hour Review -

"Safeguarding Family Wealth: Navigating the intersection of family law and estate planning"

On Monday, 13 May 2024 there were nearly 60 registrants for our Asia-Pacific chapter Zoom seminar dealing with "Safeguarding Family Wealth: navigating the intersection of family law and estate planning".

It was an engaging session exploring strategies for helping ultra-high net worth and high net worth families across multiple jurisdictions as they plan the succession of their wealth mindful of the family law impact on financial settlements.

The session was moderated by O'Sullivan Davies principal Andrew Davies (Perth) who is a highly respected senior fellow of the Academy.

Andrew was joined by three esteemed family law experts: Kares So, LLP partner Jonathan Mok (Hong Kong), Harry Elias Partnership LLP Carrie Gill (Singapore) and Y N Foo & Partners, Yet Ngo Foo (Kuala Lumpur).

The panel shared valuable insights, tips and pearls of wisdom gained from their extensive experience in this field and used the scenario below to deal with a number of specific issues. The panel delved into complex issues surrounding cross-border matrimonial disputes, the division of assets, use of trusts, nuptial agreements and the intricate interplay between family law and estate/succession planning.

The importance of proactive planning was also highlighted considering the nuances of different jurisdictions and leveraging the expertise of specialised professionals to safeguard family wealth effectively.

The emergence of the use of family offices for these high-net-worth families in Hong Kong and Singapore highlight the need for long-term planning.

There was also interesting news from Yet about the Malaysian Labuan IBFC Foundation and the opportunities that were available for tax planning and estates and how difficult it was to penetrate an entity set up in that jurisdiction.

A critical point stressed by all the speakers was the importance of actively working with clients to plan how best to structure assets in different jurisdictions in Southeast Asia especially mindful of possible challenges in a Family Court. It is often too late after there is a separation. The panel then delved into and considered the following scenario from the perspective of their respective jurisdictions:

Scenario

David Yew and his wife Sally are originally from Perth but are now successful business people living in Kuala Lumpur.

David established an engineering company in Kuala Lumpur serving the mining industry throughout Malaysia, Indonesia and Hong Kong – and is now looking to expand into other countries in South East Asia.

Sally works remotely from Kuala Lumpur as the Chief Financial Officer for UBS in Singapore.

Their two children attended private schools in Perth, Western Australia, are now independent with the eldest, Helen, married and living in Hong Kong with 2 children.

Helen holds assets for her parents in Hong Kong.

Helen's marriage of 5 years has not been smooth sailing. Helen is wanting to have a post-nuptial agreement in Hong Kong to protect her assets and that of her parents.

Matthew is presenting studying at UCL and hopes to complete an economic and commerce degree shortly. It is his plan to return to run David's engineering business (with active long-term visions of major expansion).

There is now pressure on Sally Yew to move to Singapore to live and head up the South East Asian division of UBS – David will commute between KL and Singapore.

David and Sally want to ensure protection of their significant family wealth from claims by the current partner of Helen and the new partner of Matthew.

They consult you about how best to put in place longer term plans for their children, future grandchildren and maintain the dynastic wealth. They want your advice on how best to make their structures as "family law bullet proof" as possible and how might they best secure assets in Hong Kong, Singapore, Australia and Malaysia from attack.

Thanks to the moderator and speakers for hard work, research and expertise on this fascinating area of family law.

In The News

Article 1: Japan - New custody laws

Japan's parliament has approved a legal change allowing divorced couples to negotiate joint custody of their children, replacing the current sole custody system.

These changes come after significant criticism of Japan's exclusive sole custody approach to custodial laws, which can mean one parent has no time with the children. Many believe this causes children psychological harm and prevents parents being "left-behind" and deprived from contributing to their children's upbringing.

However, supporters of the existing arrangements fear that joint custody could endanger children in cases of child abuse and subject women who suffered from domestic violence to maintain ties with their abuser.

Currently over 200,000 children are affected by divorce in Japan annually, with one in three losing contact with their non-custodial parent. The legislative change though not yet in force, signifies the nation's willingness to place paramount focus on the child's best interests.

Article 2: Thailand - Marriage Equality Bill

Thailand is nearing legalisation of same-sex marriage with a marriage equality Bill currently under Senate review and expected to be voted on in June. The Bill passed through the House of Representatives and the Upper House with ease on its first reading. It needs to pass a second and third reading in the Upper House before it can be endorsed by the King.

The Bill aims to amend the Civil and Commercial Code, replacing gender-specific terms with gender-neutral ones. This would grant LGBT couples access to equal rights, including healthcare and pensions, and allow foreign LGBT couples to marry in Thailand.

As political winds continue to shift in favour of the marriage equality Bill, we can expect to see Thailand's legal framework transform to catch up with its international reputation as a progressive sanctuary for LGBT individuals.

Article 3: China – Supreme People's Court & Divorce Economic Assistance

China's Supreme People's Court is reviewing public feedback on Article 20 of the Civil Code, which mandates economic assistance for financially disadvantaged parties in divorce cases.

This provision aligns with traditional Chinese customs: even though the couple has separated, they should still fulfill their obligation to each other as promised when they first married.

Assistance division allows the courts to order temporary housing, rental payments, or residence rights ensuring a basic living standard.

As such, some experts fear this could be a deterrent for couples who have significant economic disparities from getting married in fear of being forced to provide financial support in the event of divorce.

Article 4: Malaysia - Single mother sentenced to whipping for 'khalwat' offence

A single mother has been sentenced to six strokes of the cane and a fine equivalent to \$1,140, in default eight months in jail for committing 'khalwat': the act of being with a man that was not her husband or 'mahram'.

The woman had previously been convicted of a similar offence in 2018 and was fined.
