LESLEY PODESTA: Lesley is the CEO of the Alannah & Madeline Foundation. Lesley came into the not for profit sector after undertaking a number of senior roles in the Australian government – she was the head of the Office of Aboriginal and Torres Strait Islander Health for nearly five years and among many other innovations, introduced the Nurse Family Partnership to Australia with Professor David Olds. She also led the

development of the Australian government National Incident Room where the medical response to the Bali bombings, the Jakarta bombings and the South East Asian tsunami were managed. Lesley also led our response to SARS, Avian Influenza, HIV, Hepatitis C and the National Immunisation Program.



SALLY NICHOLES: Sally is a leading family lawyer who focuses on all aspects of family law. Sally has particular expertise in international family law disputes, property cases involving complex corporate and trust structures, and disputes between parties to a same-sex relationship and advising schools on their family law obligations. She has also had an extensive involvement in international issues concerning the wellbeing of children. Sally is an accredited independent children's lawyer and arbitrator, Deputy Chair of the

Board of the World Congress on Family Law and Children's Rights and has been, until recently, Chair of the Lasallian Foundation which provides education and related programs for the empowerment of children and young people in the Asia-Pacific region. NICK DUGGAL: Nick assists independent schools on all aspects of their legal requirements, including around school governance, enrolment, teacher conduct, student conduct, outsourced program providers, discrimination laws, privacy and health law obligations, mandatory reporting requirements, the Child Safe Standards, employment and commercial matters.



Since 1993 Victoria Police has been responding to internet based child exploitation offences via a team of investigators embedded within the Sexual Crimes Squad. In July 2012 Taskforce Astraea was established in response to contemporary trends in internet child exploitation. In October 2014 the Australian Federal Police - Child Protection Operations and Taskforce Astraea

merged to form the Joint Anti-Child Exploitation Team (JACET) [pronounced jacket] which reflects the growing international influence of our investigations into offences. JACET is staffed by 17 Victoria Police members and 10 AFP members. JACET will respond to and take primary investigation accountability for:

- Commercial/organised manufacture or large scale distribution networks of child pornography;
- Online child exploitation requiring a specialist response; and
- Organised/cross-jurisdictional child prostitution offending.
